#### Collin's Law Report 2022-2023

Published January 11, 2023

As part of The Ohio State University's commitment to promoting a safe and healthy campus environment, members of the university community have the right to be free from all forms of hazing, which impede the realization of the university's vision of being a 21st-century public, land grant, research, urban, and community-engaged institution. The university does not tolerate hazing in any form and all members of the university community must conduct themselves in a manner that supports an environment free from hazing.

In compliance with Collin's Law, the following report identifies all hazing violations under the Code of Student Conduct from October 7, 2016, through the publication date.

Personal identifying information for individual students, including organization names, has been removed in accordance with the Family Educational Rights and Privacy Act of 1974.

Collin's Law requires universities to report hazing violations for the last five years no later than January 15, 2023. However, Ohio State already publicly posts social fraternity and sorority conduct history and information about registered student organizations whose registration status has been revoked.
